**AGENDA: 2 ( a ): Proposal for procurement / import of furniture by the Developer for DC's office.**

M/s. Sri City SEZ Private Limited (Developer) vide letter dated 30.0.2015 has submitted a proposal for import / procurement of office furniture for the newly constructed office of the DC, Sri City SEZ, at the non processing area, Sri City Multi Product SEZ, as per the Annexure 'A.

The above proposal was considered / approved by the Development Commissioner, Sri City SEZ vide this office letter dated 05.10.2015.

In terms of Rule 27 of SEZ Rules, the Unit /Developer may import / procure capital good, raw materials, including furniture without payment of duties and taxes for the development and maintenance of the Zone, subject proper utilization of the goods.

In case of any doubt as to whether any goods or services are required by the Unit / Developer for authorized operations or nor, it shall be decided by the Development Commissioner, in terms of Rule 27(2) of SEZ Rules, 2006.

Hence, the above proposal is submitted for ratification of UAC.

**AGENDA: 3 ( a ): No Proposal has been received for setting up unit in Sri City SEZ.**

**AGENDA: 3 ( b ): Proposal for approval of broad-banding / additional product – Reg.**

M/s. Sutures India Private Limited was issued LOA for manufacture and export of Surgical sutures and Surgical mesh (**ITC/HS classification: 9018 39 90**) The unit has commenced its operations with effect from 17<sup>th</sup> January, 2013 and effecting exports to various countries.

M/s. Sutures India Private Limited vide letter dated 23.11.2015 has requested to accord permission for broad-banding / addl. Product namely **Heamostat (ITC/HS classification : 3006 10 20)**.

The Unit has submitted process flow chart of the manufacturing of proposed product namely Heamostat. The unit has also submitted requirement import / indigenous capital goods, raw materials for the proposed product.

However, the proposed product of **Heamostat** is free of export .

The above proposal for manufacture and export of additional product may be considered / approved by UAC, in terms of Rule 19(2) of SEZ Rules, 2006.

**AGENDA : 3 ( c ) :** M/s. Astrotech Steels Private Limited has requested to accord approval for the following service for exemption of payment of service tax, in terms of Notification No. 12/2013 dated 1.7.2012.

### 1. BUSINESS AXILLARY SERVICE

The proposal was placed in the UAC meeting held on 24.8.2015 and the same was deferred.

Now, the unit vide letter dated 26.10.2015 has submitted the above proposal with explanation, since as the above service was not falling under the default list of service, issued by Ministry of Commerce & Industry's letter dated 9.7.2014.

**AGENDA: 3 (d):** M/s. Astrotech Steels Private Limited was granted approval to engage a contractor namely M/s. **AGENDA : 4 ( a ):**


Units, which have completed one year of operation and above as on 31.03.2015 (for 2014-15) from the date of commencement of commercial production, have to be monitored as per Rule 54 of SEZ Rules, 2006. The Annual performance report is required to be submitted before UAC for consideration.

There are 20 (16 Mfg. + 4 units in FTWZ) units, which have completed one year or more of operations as on 31.03.2015. Review of 11 manufacturing units have been completed and submitted in the UAC, held on 29.7.2015 and 24.08.2015. The status of the remaining 9 units are as under :
