Agenda Item No. 2 : Request for enhancement of capacity of production (phase-III) by M/s. Vital Paper Products Private Limited , a SEZ Unit in Sri City – Subsequently permission for expansion of factory building for enhancement of proposed capacity of production.

M/s. Vital Paper Products Private Limited was granted Letter of Approval vide No. 22/Sri City- 39/SSEZ/2011 dated 13.08.2012 for manufacturing and export of **Sheeting the paper jumbo Reels** with an annual capacity of 25000 MT per annum. But unfortunately the product could not be exported by the unit under various trade scenarios.

Upon the request, the unit was granted for enhancement of the capacity for manufacturing and export of **paper stationary products for school and office**, as the details given below:-

The unit was also granted additional requirement of capital goods for a value of Rs. 255.00 Lakhs (Imp CG - Rs.29.00 Lakhs + Indg CG - Rs.226.00 Lakhs) and additional requirement of raw materials, packing materials, consumables etc., for a value of Rs. 3206.00 Lakhs (Imp CG - Rs. 762.00 Lakhs + Indg CG - Rs.2444.00 Lakhs) for a period of five years. This proposal was approved by UAC in its meeting held on 10.05.2013.

The unit has commenced its operations w.e.f. 15.03.2013. However the unit has made exports for a value of Rs. 31.54 crores up to 25.09.2015 and effected imports for a value of Rs. 12.19 crores. The unit is maintaining positive NFE as on date.

Now the unit has submitted a proposal for enhancement of capacity of production (as phase-III), as the details are furnished here under:-
