AGENDA: 2 (a):

M/s. Sri City Pvt. Ltd., Developer vide letter No.090/DC/UAC dtd. 09.03.2015 requested for approval for increase in area of FTWZ from 50 acres to 59.62 acres by addition of 9.62 acres and realignment of FTWZ boundary by addition and deletion of area to allow clear and better plot options to their customers in pipeline. They submitted Maps with Survey Nos. for existing FTWZ area and Proposed FTWZ area for approval. The proposal is within the condition of Rule 5 (2) (c) of SEZ Rules, 2006, i.e., within 20% of Processing Area of SEZ.

The proposal of the unit is placed before the UAC for **approval** please.

M/s. Everton Tea India Pvt. Ltd., vide letter dtd. 28.02.2015 (**copy enclosed**) requested for approval for further enhancement (3rd) in production capacity in respect of item viz., "**Paper Enveloped Tea Bags**" from 16 Million Bags Per Month to 22 Million Bags Per Month stating that they have received **substantial orders from Europe**.

The unit has submitted projections for additional exports, requirement of Imported and Indigenous CG, RM etc., and also construction material to create additional space for storage of RM etc. Since the additional imported machinery is expected to arrive on 20.03.2015, approval for enhancement in production capacity and projections has been given by the Development Commissioner vide letter No.23/Sri City-30/SSEZ/2011 dtd. 03.03.2015 (**copy enclosed**) so as to enable the unit to start production with new machinery within this financial year. The proposal is as per Rule 19 (2) of SEZ Rules, 2006.

M/s. Powergas Energy Private Limited a new unit under implementation, requested vide letter dtd. 13.03.2015(copy enclosed) for approval for undertaking additional activities viz., EPC Contracts, Trading and Merchant Exports for Compressed and Power Projects in African Continent.
