#### <u>AGENDA: 3(a)</u>

Proposal of M/s. Sutures India Pvt. Ltd., an unit in Sri City SEZ for Further Enhancement in Production Capacity in respect of Item of Manufacture viz., Surgical Sutures USP from 18 lakhs Dozens to 30 lakhs Dozens Per Annum and projections on additional requirement of Imported and Indigenous Capital Goods / Raw Materials / Components / Consumables / Spares/ Packing Materials for 5 years and also construction materials required for creation of additional space for production, as under.

#### **Additional Projections / Requirements :**

**I.** Further enhancement in production capacity in respect of item of manufacture viz., **Surgical Sutures USP** from 18,00,000 Dozens Per Annum to 30,00,000 Dozens Per Annum as per Rule 19 (2) of SEZ Rules, 2006, with following additional projections required for enhanced capacity for 5 years.

- A. FOB value of Exports US \$ 24420 Thou/Rs. 14652 lakhs.
- B. Imports: CG Rs. 100 lakhs + RM etc. Rs. 2400 lakhs (Total Rs. 2500 lakhs / US \$ 4166 Thou).
- C. **Indigenous:** Construction Materials required for providing Additional Factory Space/Expansion of Factory building Rs. 208 lakhs. Capital Goods Rs. 325 lakhs. Raw Materials etc. Rs. 3600 lakhs.

Approval for the above have been issued as per Rule 19(2) of SEZ Rules, 2006 vide letter dtd.30.05.2014

The Unit Approval Committee discussed and **ratified** the proposal.

The following three proposals of M/s. Kusakabe India Pvt.Ltd., an Unit in Sri City SEZ for approval :

I. Post- facto approval for excess Import of Capital Goods, Procurement of Indigenous Capital Goods and Indigenous Construction Materials viz., Cement & Steel as per Annexure –A attached to letter No. No. KIPL/FIN/2014-15/01 Dtd. 02.07.2014.

- II. Amendment in the item of manufacture in the Letter of Approval inclusion of Parts of Tube & Pipe Mill Equipment in the LoA as per list attached Annexure 'A. and revised projections as per Annexure 'B' attached to the Unit's letter No. KIPL/FIN/2014-15/02 Dtd. 02.07.2014.
- **III.** Approval for Trading Activity for import in F.C. and export to Iran in Indian Rupees from the existing Unit after construction of building for trading. Letter No.KIPL/FIN/2014-15/03 Dtd. 02.07.2014.

The Unit Approval Committee discussed and approved the Proposals I & II above.

As far as proposal **III** above is concerned, the UAC after careful examination of proposal and DGFT Notifications No.105(RE-2010)/2009-2014 dtd. 05.03.2012, No.17(RE-2013)/2009-14 dtd.10.06.2013 and No.79(RE-2013)/2009-2014 dtd. 30.04.2014 submitted by the Unit during the meeting and deliberations, the UAC **decided to reject** the proposal on the following grounds :-

- 1. The proposed activity i. e., trading falls under the Provisions of Rule 18 (5), hence not allowed from the existing unit in the Processing Area of SEZ.
- 2. As per Rule 18 (5) of SEZ Rules, 2006, all the transactions of a Trading Unit in FTWZ area of SEZ shall be in convertible foreign currency only.
- 3. Exports in Indian Rupees to Iran by Trading Units in SEZ are not allowed notwithstanding that exports by a DTA Unit can do exports to Iran against realization of proceeds in Indian Rupees.
- 4. The unit has not submitted any other documentary evidence that allows Iran import from Japan and also goods originated from Japan.
