The Meeting of the Unit Approval Committee was held on **29-07-2015** at 02.30 PM at Business Centre, Sri City SEZ, Sathyavedu Mandal, Chittoor District, A.P. Pin – 517 588.

Shri A. K. Choudhary, ITS, Development Commissioner, Sri City SEZ (Multi Product) and Chairperson, Unit Approval Committee welcomed the Members and apprised them briefly about the proposals placed before the Committee for their consideration. The items listed in the **Agenda and Supplementary Agenda** were discussed and following decisions were taken.

AGENDA: 2 (a): No proposal has been received from the Developer, M/s. Sri City Pvt. Ltd.

AGENDA: 3 (a):

Proposal of M/s. M S R Garments Pvt. Ltd., Chennai – 600 096 for grant of Letter of Approval for setting up an unit in Sri City SEZ for manufacture of Handmade Woolen Suits(Jacket & Trouser), Cotton Shirts and Handmade Trial Suits(Jacket & Trouser) made out of Cotton + Viscose blended fabrics. The Proposal covered under Rule 18 (6) of SEZ Rules, 2006.

The Unit Approval Committee discussed and **approved** the proposal.

Proposals of M/s. Astrotech Steels Pvt. Ltd., for (1) Approval for Enhancement in Production Capacity from 26422 MT/PA to 30000 MT/PA. (2) Broad banding approval request to include ‘Screws’ and ‘DC/AC Driven Screw Driver’ in LoA. and (3) Approval for appointment of M/s. Sri City Projects Pvt. Ltd., as principal contractor for expansion of factory.

Member from APPCB observed that as per revised CPCB guidelines, by virtue of additional investment of more than Rs. 10 Crores in Plant and Machinery, the unit will be categorised as Heavy Industry and fall under red category. He also informed to the UAC that at present M/s. Sri City Pvt. Ltd., the developer holds Green and Orange Categories approval only for SEZ & DTZ from APPCB. Unless the Developer apply for amendment for Red Category status also for Sri City SEZ & DTZ, technically the unit cannot implement the expansion. Further the unit shall have to apply to APPCB for revised categorization and obtain new CFE / CFO (Consent for Establishment/Consent for Operation).

Except for above observation of Member from APPCB, **the proposals are in order.**

The Unit Approval Committee discussed and **approved** the above three proposals subject to the following conditions:

1. The unit shall obtain prior approval from APPCB before implementation of the expansion and enhancement in production capacity.
2. The unit shall not be allowed to import or procure duty free goods related to the above proposals before obtaining CFE/CFO or other approvals as the case may be from APPCB.
3. The unit shall submit copies of approval from APPCB to this office.
4. The unit shall maintain separate books of accounts for the proposed 3 activities approved above.
5. The unit shall execute additional BLUT for the above proposals.
